MINUTES OF THE OCTOBER 18, 2018 REGULAR MEETING

The Citizen's Ethics Advisory Board ("Board") of the Office of State Ethics ("OSE") held a Regular Meeting on Thursday, October 18, 2018, in the 5th Floor Conference Room, 18-20 Trinity Street, Hartford, CT 06106.

Chair Dena Castricone called the meeting to order at 1:00 p.m.

1. The minutes of the September 20, 2018 Regular Meeting were presented to the Board for approval.

- 7. Director of Education and Communications Nicolescu presented the Education and Communications Reports. She noted that she is preparing a modular training program using upgraded software recently purchased by the OSE to be rolled out on January 1, which Board members offered to test.
- 8. Ethics Enforcement Officer Jones presented the Enforcement Division Report. He reported that there were two matters scheduled for UAPA hearings on Thursday, October 25, 2018.
- 9. Ethics Enforcement Officer Jones presented the audit reports for Open Communities Alliance, for which there were two adverse findings, and 3D Consulting, LLC, for which there were no adverse findings.

- 10. Executive Director Carson reported on the upcoming Council on Governmental Ethics Laws conference to be held in December in Philadelphia. She stated that outreach about changes to the law effective October 1, 2018 included notice to all agency ethics liaisons and updates to the website including an info sheet, links to the new disclosure form for gifts to the state and necessary expenses, and an FAQ. Finally, she reported on the annual staff retreat to update the Strategic Plan.
- 11. Chair Castricone and Mr. Farrell commended the staff for their ongoing efforts in advancing the Strategic Plan.
