### MINUTES OF THE MARCH 21, 2019 REGULAR MEETING

The Citizen's Ethics Advisory Board ("Board") of the Office of State Ethics ("OSE") held a Regular Meeting on Thursday, March 21, 2019, in the 5<sup>th</sup> Floor Conference Room, 18-20 Trinity Street, Hartford, CT 06106.

Chair Dena Castricone called the meeting to order at 1:03 p.m.

1. The minutes of the February 28, 2019 and March 7, 2019 Special Meetings were presented to the Board for approval.

- 2. Chair Castricone thanked the Board for their participation in the hearing in Docket No. 2017-15, In the Matter of a Complaint Against Charmane Thurmand. She requested that Mr. Johnston serve as the hearing officer for UAPA hearings scheduled for Thursday, April 25, 2019. Ms. Lipson volunteered to replace Mr. Johnston if he is unavailable to serve.
- 3. Acting General Counsel O'Dowd presented the Petition for Advisory Opinion submitted by Robert Clark on behalf of Governor Ned Lamont.

- 4. Acting General Counsel O'Dowd presented an overview of Advisory Opinion No. 2006-8 regarding the Board's settlement authority, after which the Board discussed the Opinion.
- 5. Mr. Chiusano discussed the Report on the University of Connecticut's Compliance with General Statutes §\_1-84 (r), regarding Faculty Consulting, noting UConn's duty to report to the Office of State Ethics instances where faculty members did not follow the requirements of this provision.
- 6. Acting General Counsel O'Dowd presented the Legal Division report. He noted that the appeals period involving Docket No. 2017-15, In the Matter of a Complaint Against Charmane Thurmand, concludes on April 22, 2019.
- 7. Ms. Nicolescu presented the Media and Training Reports. She asked Board members to follow the recently activated OSE twitter account @ethicsCT.
- 8. Deputy Enforcement Officer Wasielewski presented the Enforcement Division report. He stated that three probable cause hearings were currently scheduled: two on April 16, 2019 and one on June 6, 2019.
- 9. Deputy Enforcement Officer Wasielewski presented the lobbyist audit report for Catrala of CT. There was one adverse finding.
