Terrance Burton v. Cowlis Andrews, Chairperson, Bridgeport Housing Authority; and Bridgeport Housing Authority

The Hearing Officer's Report is amended as follows:

The above-captioned matter was heard as a contested case on July 10, 2018, at which time the complainant and respondents appeared, stipulated to certain facts and presented testimony, exhibits and argument on the complaint. The complainant, who is incarcerated, appeared via teleconference, pursuant to the January 2004 memorandum of understanding between the Commission and the Department of Correction. See Docket No. CV 03-0826293, Anthony Sinchak v. FOIC, et al., Superior Court, J.D., of Hartford at Hartford, Corrected Order dated January 27, 2004 (Sheldon, J.). SUBSEQUENTLY, THE COMPLAINANT FILED AN AFFIDAVIT, DATED JULY 10, 2018, WHICH WAS NOT NOTARIZED, WITH AN ATTACHMENT, AND REQUESTED THAT SUCH AFFIDAVIT AND ATTACHMENT BE ADDED TO HIS TESTIMONY. SUCH REQUEST IS HEREBY DENIED. THE COMPLAINANT'S AFFIDAVIT AND ATTACHMENT WILL BE MARKED AS COMPLAINANT'S EXHIBIT A, FOR ID PURPOSES ONLY.

Mark Dumas and Connecticut State Police Union v. Dora Schriro, Commissioner, State of Connecticut, Department of Emergency Services and Public Protection; and State of Connecticut, Department of Emergency Services and Public Protection

The Hearing Officer's Report is amended as follows:

- 25. Weighing all the factors related to the request, it is found that the respondent department **DID NOT COMPLY** [unduly delayed complying] with the complainants' requests in this case **WITHOUT UNDUE DELAY** and it is **THEREFORE** concluded that it violated the promptness provisions of §§1-210(a) and 1-212(a), G.S.
- [30. It is found that while the authority to *hire* more staff to help reduce the long delays in complying with requests for records under the FOI Act lies with the Connecticut Office of Policy and Management, the re-assignment and redistribution of staff and resources to do the same is within the authority and the discretion of the respondent Commissioner.]
- [31.] **30.** Consequently, it is found the respondents' violation of the promptness provisions of §§1-210(a) and 2-212(a), G.S., in this case was without reasonable grounds within the meaning of §1-206(b)(2), G.S., and is a serious concern for this Commission.
