Monthly Indicators Report

Highlights

- On July 1st, 13,107 inmates were held in Connecticut prisons and jails, an uptick from early June, but 2% drop from the figure reported last July.
- The size of the sentenced population appears to have stabilized. In recent years, the sentenced-prisoner population declined at a rate of 7-10% per year. This year, the sentenced inmate population was down only 1% compared to July 2018.
- Growth in the size of the special parole population continues to slow. Parole and community services added a net increase of only 8 offenders, on special parole status to its roster of clients in June.
- Statewide arrests are down for the sixth consecutive month. Year-to-date, there were 2,160 fewer arrests in 2019 than in 2018.
- On July 1, 2019 - 241 fewer inmates were held on bond compared to last July. Pretrial offenders held on bonds under \$100k account for all of the reduction (table 5a).
- Only 326 sentenced offenders were released through one of the DOC's discretionary release mechanisms during the month of June. Last June 429 were released, 24% more. Year-to-date, discretionary releases are down 13% compared to 2018.
- Chart 2a provides an illustration of the adaptability of state systems to adjust to circumstances. A large and sudden increase in the state's prison population following criminal justice reforms in the early 1980s, resulted in a dramatic expansion of a little used discretionary release program to radically reduce overcrowding in CT DOC facilities.

Prison Population Forecast

The state's prison population rose moderately during June. The average daily count (ADC) for the first week in July was 13,052, only slightly higher than the June figure of 13,013. The uptick in this month's prison population brought the OPM forecast into closer alignment with the actual count.

During a typical year, the prison population expands as summer progresses, driven largely by increases to the pretrial population. Over the last few years, increases among pretrial population have been modest and offset - almost completely - by contraction of the sentenced population. The result, net decreases in the total prison count. This year the sentenced population has relatively remained flat while the pretrial population ticked up slightly.

Although the monthly pre-trial population increased last month to 3,115, the number of pre-trial prisoners remains down compared to July 2018, when 3,297 pre-trial offenders were incarcerated (See Table 2).

January 1, 2017 through February 1, 2019

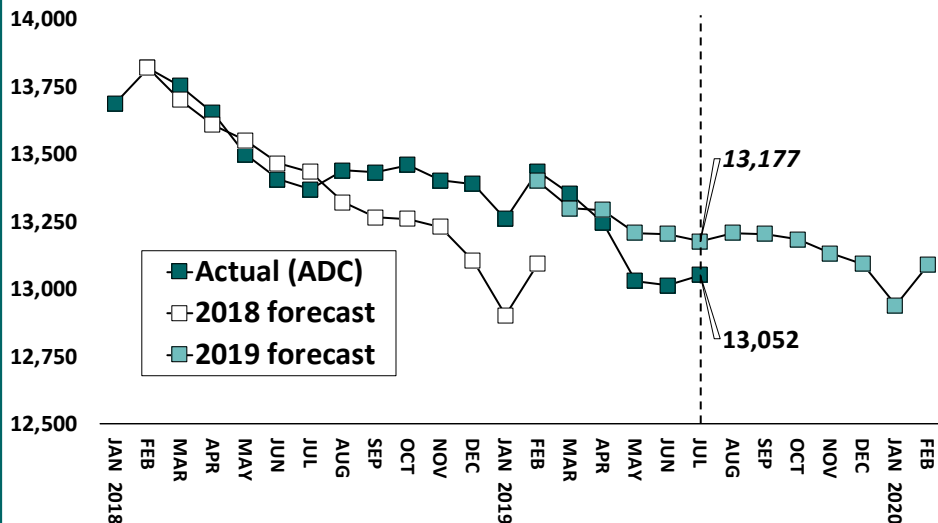


Chart 2 - Criminal justice, monthly counts and flows

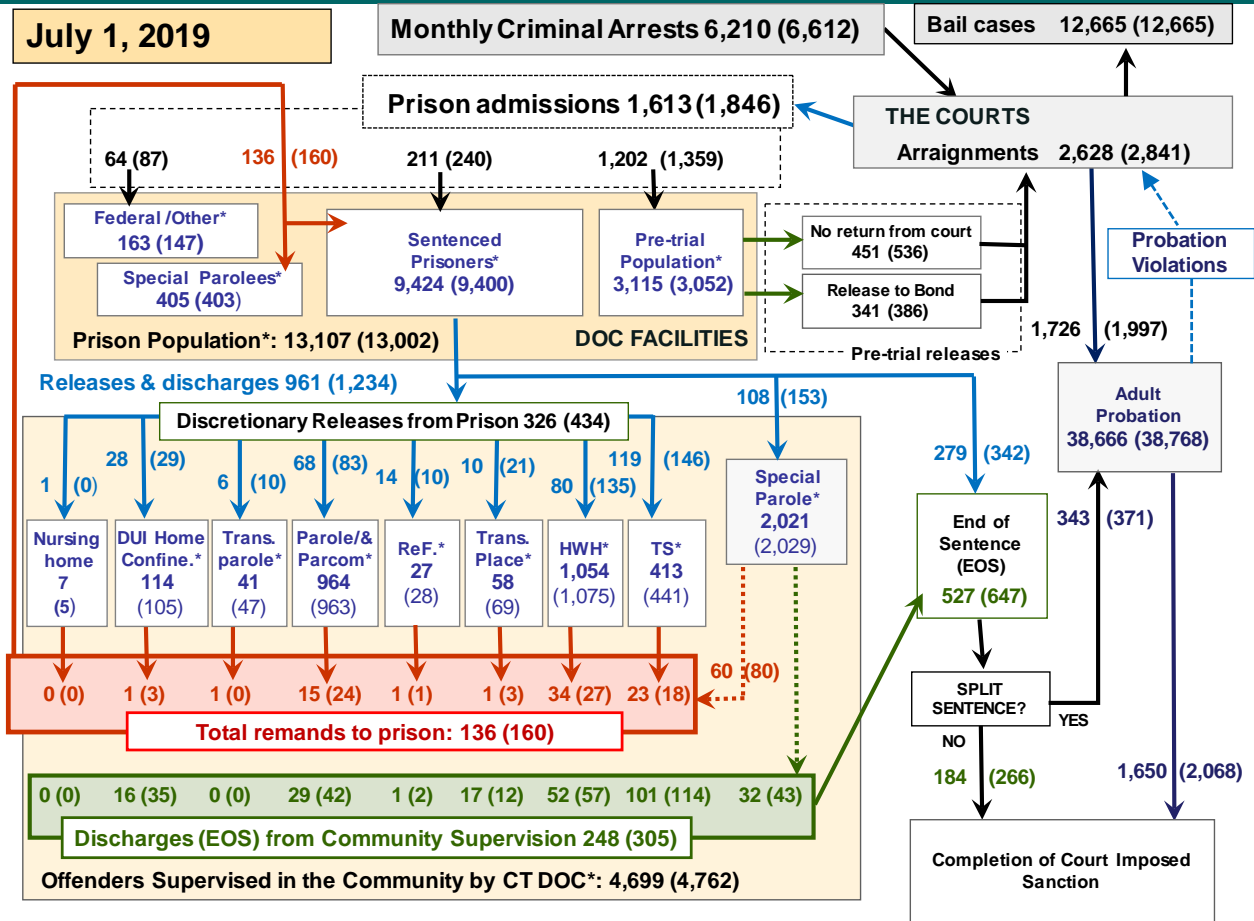
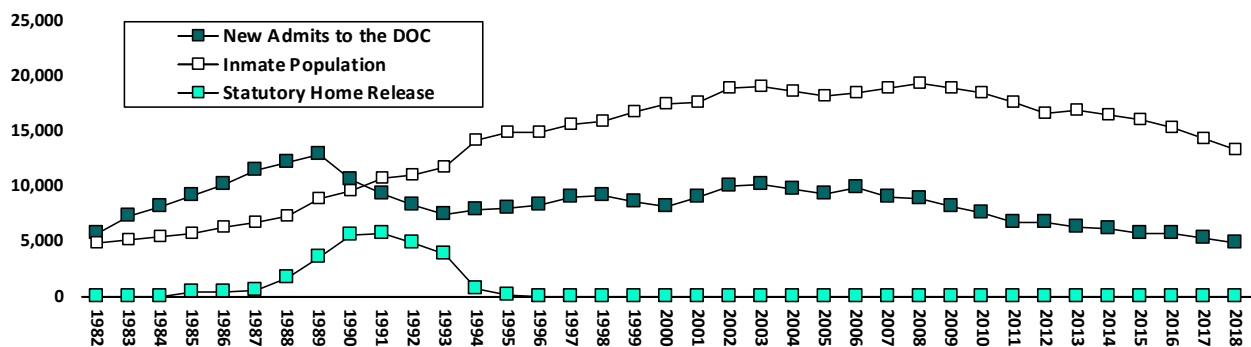

Last month, this space featured a chart of the number of new persons admitted to the DOC against total DOC admits. With the current prison population back roughly where it was in 1993, we have decided to look back to try to understand some of the dynamics that drove mass incarceration in the state.

In 1981, the state moved from indeterminate sentencing system to a determinate system which imposed fixed prison terms and gave the DOC authority over releases.

On the back of longer sentences, the prison population swelled. According to a 2000 General Assembly report on Factors Impacting Prison Overcrowding, Supervised home release (SHR) quickly became a mechanism for prison overcrowding, and eventually the legislative intent of the program and the overall criminal sentencing policy were undermined by the DOC's need to free prisoner beds for incoming inmates. At the height of SHR inmates were serving only about 10% of their court-imposed sentences.

First week of the month, avg. daily count (ADC)

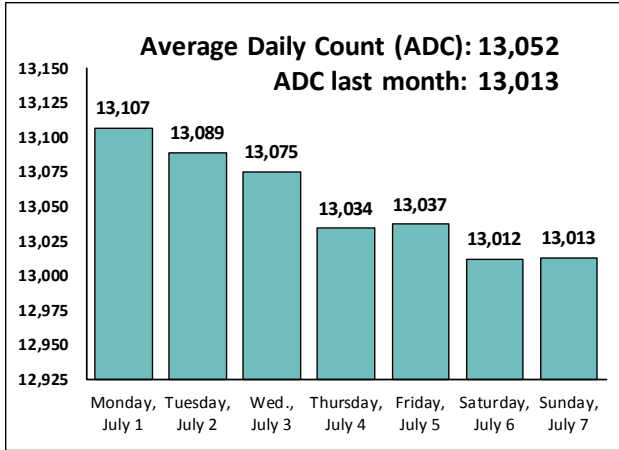


Chart 6 – Monthly DOC Admissions

May 2018 through June 2019

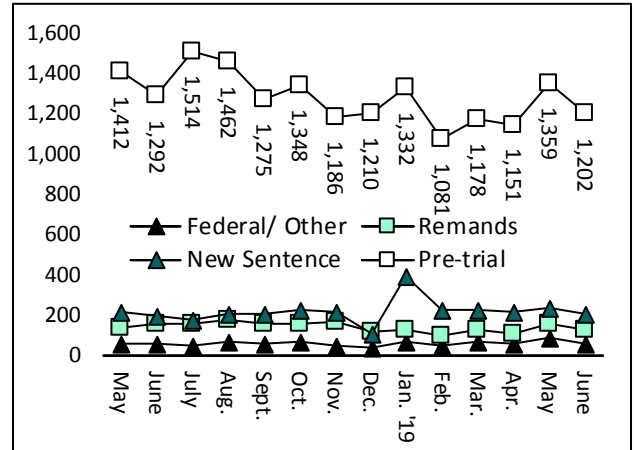


Chart 4 – Prison population, first-of-month

2016, 2017, 2018 and 2019

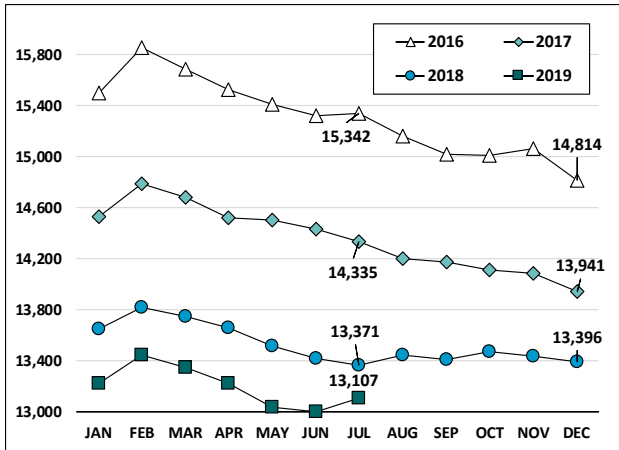


Chart 7 – Remands from community release

June 2019

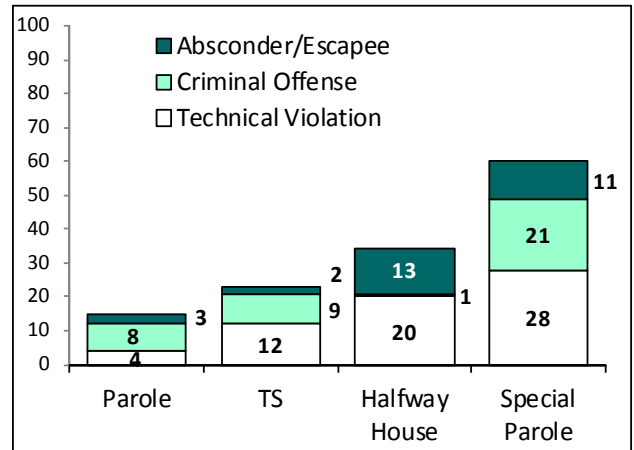


Chart 5 – Statewide criminal arrests

2018 and 2019

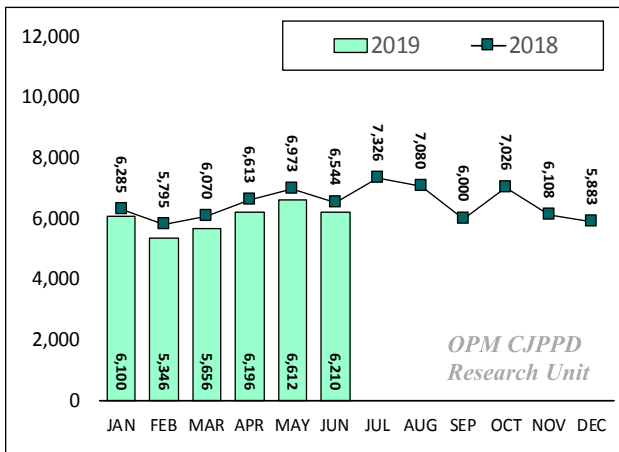
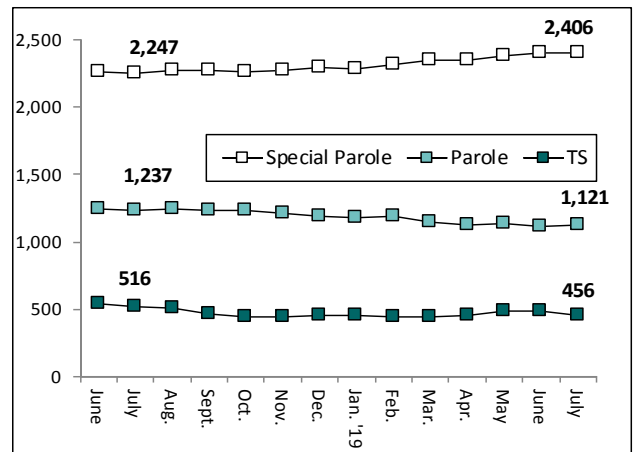


Chart 8 – DOC community supervision
