The Agency has completed the implementation of the EMR system for all the modules in clinical operation and fiscal operation. The Agency recognizes the fact that the system will require updates and modifications to meet the needs of the operation from time to time.

The Agency replaced the old paper-based documentation of patient care and the antiquated legacy patient care system in the agency with ADL health record system (EHR) in compliance with the HITECH Act. The DVA's EHR system offers an enterprise-wide approach to meeting the needs in different aspects of patient care -- medical, nursing, clinical ancillary, medications, billing, accounts receivables, etc. The ADL system ensures compliance with the HIPAA regulations and updated CMS requirements.
