II. COST OF LONG-TERM CARE IN CONNECTICUT



The Partnership's publication, *Cost of Long-Term Care in Connecticut*, has been revised to reflect updated nursing facility and home care costs. The average private pay rate for a Connecticut semi-private nursing facility room increased **1.75%** from last year to **\$414 per day** or over **\$151,000 per year**. Over the last five years the inflation rate for nursing facility care has averaged **2.4%** per year and the average annual inflation rate since 1988 in Connecticut has been **5.1%**.

The **Cost of Long-Term Care** report also includes average private pay rates for a variety of home and community-based services, including skilled services, such as skilled nursing visits, and therapies and non-skilled services, such as adult day care and homemaker services.

III. RATE INCREASE ACTIVITY



<u>CNA</u>:

In March 2017, CNA requested a 229.5% rate increase for some older Partnership and non-Partnership policies. **This request is under review by the Insurance Department.**

JOHN HANCOCK:

In March 2017, John Hancock requested rate increases ranging from 8.1% to 125.2%, depending on the policy form, for some older Partnership and non-Partnership policies. This request is under review by the Insurance Department.

There are no other rate increase requests under review by the Insurance Department for Partnership policies.

IV. PENN TREATY/AMERICAN NETWORK LIQUIDATION

Effective March 1, 2017, Penn Treaty/American Network officially was declared insolvent.  All CT Partnership policyholders who receive care in a CT licensed nursing facility are entitled to a 5% discount off the private pay cost for room and board and services in the facility. With an annual private pay rate of over \$151,000, that is over a \$7,500 discount.
