Subject: <u>Change in form for Entry Requirements for Appointment for</u> New/Lateral/Comparative (POSTC 51)

POSTC form 51 has been revised to more clearly conform to C.G.S. 7-291c (Public Act 15-4). Question number 9, which is required for lateral transfers and Comparative Certification Applicants only, has been revised. First, additional space has been provided to enter the name and rank of the person contacted at the previous law enforcement unit(s) providing information. Second, the statement "Additionally, there is nothing in the applicant's background, disclosed to us, that would be a disqualifier pursuant to CGS 7-291c" has been added to the signature block on page two. Lastly, it has been made clearer that this is a sworn form and that false information is punishable under 53a-157b False Statement 2nd degree.

This form will be required of all New, Lateral, and Comparative Certification applicants hired on or after July 1, 2016. The revised form has been uploaded to our website under the Certification page.
