Water must comply with Section 10-221q of the Connecticut General Statutes (C.G.S) and the USDA Smart Snacks nutrition standards for competitive foods. Water sold in elementary and middle schools must be unflavored (with or without carbonation) and cannot contain added sugars, sweeteners, (including nutritive and nonnutritive sweeteners), artificial sweeteners, or caffeine. Water sold in high schools can be flavored or unflavored (with or without carbonation), but cannot contain added sugars, sweeteners, (including nutritive and nonnutritive sweeteners), artificial sweeteners, or caffeine. The portion size of flavored water (with or without carbonation) is limited to 20 fluid ounces. These requirements apply to all public schools, regardless of whether the district implements Healthy Food Certification (HFC) under C.G.S. Section 10-215f.
