- Early childhood, worked with Maria Synodi
- Indicator 6, LRE for Children 3, 4, 5 years old. SDE did not report on this because the federal
 government is changing the guidelines so there are no unmet needs for SAC
- 12- FAPE by age 3, no unmet needs for SAC
- Indicator 7, early childhood outcomes- Joanna provided a handout with timelines, history of activities, and data surrounding this indicator
- SDE has met requirements for the three activities of indicator 7.

Recommendations (DRAFT): continue recruitment and retention of highly qualified PreK special educators

- Continue to create inclusive opportunities for preK children
- Continue to find ways to inform families transitioning in special education
- Continue to assist in training of teachers and other personnel in nuances of determining if delays are related to disability or lack of experiences/opportunities,
- Continue to caution against possible institutional racism for white and non white students struggling
 with Positive social-emotional skills, acquisition and use of knowledge and skills (early
 language/communication, and early literacy), and appropriate behaviors.
- Needs to be a one page executive summary that lists the recommendation.
- Members can email feedback to Joanna.

Charlyne emailed report to Brenda-looked at due process cases statewide for the last three years. Looking for trends in how many cases mediated, resolved, went to hearing, etc. Most cases went to mediation and findings are not published. Most cases were around independent evaluations-Districts brought parents to due process around independent evaluations for students.

CT Benchmark Assessment System-testing data base, 60 districts participating grades 3-8

*Teachers need to be taught how to write goals and objectives

Indicator 9-Zero districts are under or over represented

SRBI-looked at information from CPAC, other state's documents, worked with Pat Anderson and Perri Murdica.

3 areas of unmet need

Professional development-What training exists for staff to be able to implement interventions with fidelity? No requirement s by the state, teachers get CEUs each year, districts pay for authorized training.

Recommendation for consistent training across the state

Development of professional framework for training across the state.

Accountability-How will the state track student participation in SRBI? How long are students spending in SRBI before mastering content,

*Develop student tracking system for students participating.

Involvement for Families? Districts are not under obligation to abide by the guidelines.

The challenge is how to make a recommendation from SAC around SRBI which is general education driven.

Update on indicator 5 and 8

5 C was not met. Emphasis on increasing Time with Non-Disabled Peers. Issues are revolving around quality of education for students with disabilities

Indicator 8-

Surveys mailed, response rate was 20%, parent workgroup meets six times a year, SDE is providing training to districts with high response of parent dissatisfaction. Michelle is continuing to follow up on these indicators.
