Report of the Chair

- The president informed committee of resignations and is looking to build membership.
- Isabelina will send out chart of vacancies. Most vacancies are legislative positions.

**Report of Chief** 

- Isabelina Rodriguez informed committee that she is now the Interim Chief Academic Officer. Special education is now combined with the Academic Office and she is overseeing both departments.
- Isabelina gave an overview of the department's goal of ESSA (Every Student Succeeds Act) formerly NCLB. The focus of ESSA is closing the achievement gap. ## Committee Reports

CPAC

- The focus is on accessibility of services, working outreach programs, they are looking at new partners and ways to leverage resources with effective parents.

## OPA

- Colin Milne reported on the transitioning of OPA from state to private non-for-profit. Concern is with the speed in which the transition is being done. A transition plan has to be in place by November with full transition taking place in July 2017.
- OPA has received an increase in calls from parents of 3 and 4 year olds.
- Colin Milne gave a brief overview on the agency's position on the CCJEF decision.
