PRESCRIBED FORM FOR RETURN OF VOTES CAST AT A MUNICIPAL OR  
TOWN COMMITTEE PRIMARY  
(C.G.S. §9-440 and . §9-314(b))

The head moderator shall file a preliminary list of the vote totals produced by the tabulators not later than midnight on election day. Thereafter, the head moderator shall file a complete head moderator's return with the Secretary of the State by electronic means not later than forty-eight hours after the close of the polls. The head moderator shall also seal and deliver an original head moderator's return to the Secretary of the State not later than the third day after the election.

The head moderator in each town shall deliver to town clerk one copy of duplicate certificate of votes cast for candidates not later than forty-eight hours after the close of the polls. Use additional pages, if necessary.
