Item Purpose: Acquisition of 7,971±SF of land in fee simple; 12,620±SF slope easement; and

26,970±SF construction easement for the purpose of construction access, temporary roadway for detour and other rights acquired on connection with the

construction of the aforesaid roundabout.

The purpose of the project, initiated in 2011, is to alleviate congestion and improve safety by constructing a roundabout where Route 111 (Monroe Turnpike) intersects with Route 110 (Shelton Road), in Monroe. Currently the intersection experience long queues and delays along Route 110 during peak hours. There were 27 recorded crashes between 2008 and 2010, including one fatality. Roundabouts improve safety by reducing speeds, eliminating left turns, reducing the number of decisions drivers need to make, and reducing the total number of vehicle conflict points. In addition to new sidewalks, the aesthetic features include landscaping, the bell tower, decorative light posts at the crosswalks, truck apron and splitter islands, retaining walls with decorative safety fence and a reset stone wall on the edge of the Firemen's Field. The cost is \$4.1 million using federal (80%) and state (20%) funds, and the construction is planned to being in the spring of 2017.

The subject property consists of 4.34 acres of residentially zoned, vacant land. There is public water available to this site. Mature trees line the boundaries, including the road frontage along Routes 110 and 111. The site is used for training purposes and to hold public events such as fairs and carnivals.

The project requires DOT to compensate the Grantor for a strip of land that extends along the property's Route 111 frontage for a length of about 504 feet, and then continues another 75 feet along the intersection of Route 111 and Route 110. The total area taken is 7,971 SF. The Grantor will also be compensated for a 12,620 SF slope easement along the street frontage; and a temporary construction easement encumbering 26,970 SF for the 2 year project duration.

The appraisal was completed by the DOT and concluded a unit value of \$2.05/SF for the site before and after the takings. The total compensation for damages is \$29,300 for the permanent rights acquired and \$11,100 for the temporary construction easement, for a total of \$40,400.

Staff recommended Board approval of the item. The acquisition complies with Section 13a-73(c) of the CGS which governs the acquisition of property by the commissioner of transportation required for highway purposes. The award for damages in the amount of \$40,400 is supported by the DOT appraisal report prepared as of April 11, 2016.
