Introduction

- The Monitor reserves the rights, authorities and responsibilities granted in the Monitoring Order of December 1, 1992 as modified, and all the rights, authorities and responsibilities granted in the October 7, 2003 Stipulation and Order (No. 447) all of which are incorporated in this Exit Plan by reference.
- The Monitor reserves the right to modify the measurement procedures to be used to determine and sustain compliance with any outcome measure herein until July 1, 2004 after which time, there shall be no changes except as may be ordered by the Court.
 LINK and other reporting options will be finalized during this period.
- 3. The Juan F. class is:
 - A. All children who are now, or will be, in the care, custody, or supervision of the Commissioner of the Department of Children and Families as a result of being abused, neglected or abandoned or being found at risk of such maltreatment; and¹
 - B. All children about whom the Department knows, or should know by virtue of a report to the Department, who are now, or will be, abused, neglected or abandoned, or who are now, or will be, at serious risk of such maltreatment.
- 4. The United States District Court for the District of Connecticut retains continuing jurisdiction over this action until the Court terminates such jurisdiction.
- 5. The Defendants must be in compliance with all of the outcome measures, and in sustained compliance with all of the outcome measures for at least two quarters (six months) prior to asserting compliance and shall maintain compliance through any decision to terminate jurisdiction. The Court Monitor shall then conduct a review of a statistically significant valid sample of cases files at 96% confidence level, and such other measurements as are necessary, to determine whether Defendants are in compliance. The Court Monitor shall then present findings and recommendations to the District Court. The parties shall have a meaningful opportunity to be heard by the Court Monitor before rendering his findings and recommendations.
- 6. This Exit Plan delineates specific outcome measures whose achievement are a prerequisite for termination the Court's jurisdiction over this action. Specific definitions, guidelines, interpretations and measurement methodology are listed for each outcome measure. The only enforceable measurements are the actual outcome measure that are bolded and placed in text boxes.
- 7. The Defendants shall provide funding and other resources necessary to fully implement the Exit Plan.

¹ For the purposes of Exit Plan Outcome Measure reports, all children with a **Legal Status** of **Commitment** – **Delinquent** will be excluded (where applicable). All children with a legal status of **Commitment** – **Dual** will be included (where applicable).

Outcome Measure 1: Commencement of Investigation

Measure

DCF shall assure that at least **90%** of all reports of children alleged to be abused, or neglected, shall be prioritized, assigned and the investigation shall commence within the timeframes specified below.

If the report of child abuse or neglect is determined by the DCF Hotline to be:

- A. A situation in which failure to respond immediately could result in the death of, or serious injury to a child, then the response time for commencing an investigation is the same calendar day Hotline accepts the report.
- B. A non-life threatening situation that is severe enough to warrant a 24 hour response to secure the safety of the child and to access the appropriate and available witnesses, then the response time for commencing an investigation is 24 hours.
- C. A non-life threatening situation that, because of the age or condition of the child, the response time for commencing an investigation is 72 hours.

Definitions

- The **commencement of an investigation** occurs when the DCF investigator attempts to make face-to-face contact with the parent or person responsible for the child's care, and/or with the child(ren).
- A report of alleged abuse, neglect, or a child in danger of abuse or neglect comes into existence when the DCF hotline accepts a complaint for investigation and designates a response time for the commencement of the investigation.
- A report is **prioritized** by the DCF Hotline when it designates a response time of the same calendar day, 24, or 72 hours for the commencement of the investigation.
- A report is assigned when the DCF area office designates an investigator to commence the investigation within the time frames specified in this outcome measure.
- The Hotline shall determine the primary language of the family, if possible, so the case is assigned to an investigator who speaks that language, or DCF shall secure an interpreter to accompany the investigator.

Measurement Procedure:

- A. The Monitor shall determine if this outcome has been achieved through LINK quarterly reports. The percentage will be determined by averaging the three (3) months in each quarter. DCF will report quarterly on the barriers to meeting this measure.
- B. The Monitor shall find that DCF has complied with this outcome measure when DCF has documented this outcome measure in LINK for two consecutive quarters, maintains compliance through exit from this action, and the Monitor has verified compliance with this outcome measure.

Data Mapping

Pending LINK Change. Release scheduled for May 2004.

One (1) calendar month beyond release of LINK change is required to produce the first report.

Outcome Measure 2: Completion of the Investigation

Measure

At least **85%** of all reports of alleged child maltreatment accepted by the DCF Hotline shall have their investigations completed within 45 calendar days of acceptance by the Hotline.

Definitions

The completion of the investigation occurs when the investigator has interviewed each family member, including the parents, other adults and all children in the home as well as necessary collateral contacts and the investigator's DCF supervisor verifies the investigator's determination of substantiation or non-substantiation and the determination entered in LINK.

Investigations shall be conducted by workers who speak the primary language of the family or the investigators shall be accompanied by an interpreter.

Measurement Procedure

- A. The Monitor shall determine if this outcome has been achieved through LINK quarterly reports. The percentage will be determined by averaging the three (3) months in each quarter. DCF will report quarterly on the barriers to meeting this measure.
- B. The Monitor shall find that DCF has complied with this outcome measure when DCF has documented this outcome measure in LINK for two (2) consecutive quarters, maintains compliance through exit from this action, and the Monitor has verified compliance with this outcome measure.

Data Mapping

Query the LINK database to determine all Investigations completed during the period. For each Investigation completed during the period, subtract the CPS Report accept date from the Investigation Completion Date to determine the number of days the Investigation was open.

Outcome Measure 3: Treatment Plans

Measure

In at least **90%** of the cases, except probate, interstate, voluntary and subsidy only cases, clinically appropriate individualized family and child specific treatment plans shall be developed in conjunction with parents, children, providers and others involved with the case and approved by a DCF supervisor within 60 days of case opening in a treatment unit, or a child's placement out-of-home, whichever comes sooner, and for each six (6) month period thereafter.

Approved by the DCF Supervisor, means the DCF supervisor verifies and confirms that the functions of a written treatment plan are developed and used to:

- A. Identify in a time limited and goal oriented format the problem areas, needs and proposed services to be provided to all children, parents, relatives and caretakers who are active participants in the case.
- B. Document and describe reasonable efforts to prevent out-of-home placement of children.
- C. Define mutual responsibilities and expectations of children, parents, caretakers and service providers toward reaching identified case goals.
- D. Document and describe reasonable efforts to reunify children with their families in a timely manner.
- E. Determine sibling and parental visitation schedule if siblings are not placed together.

The individualized family and child specific treatment plans are the written working agreement between the child, family, caretakers if any, service provider (s) and DCF. The agreement describes and documents the child and/or family's service needs as well as what DCF, the family, and/or the child is required to do to achieve the goals of the plan. This includes all in-home and out-of-home cases except probate, interstate, voluntary and subsidy only cases.

Treatment plans shall be written in the primary language of the family and/or child. Treatment planning conferences shall be conducted in the primary language of the family and/or child.

Measurement Procedure

- A. DCF will randomly select 25 cases quarterly for a qualitative review, including unannounced attendance at the treatment planning conferences, to determine if this outcome measure is being achieved and to report on the barriers to meeting this measure.
- B. The Monitor's Office will randomly select 15 cases quarterly for a qualitative review, including unannounced attendance at the treatment planning conferences, to determine if this outcome measure is being achieved.
- C. The Monitor shall find that DCF has complied with this outcome measure when DCF has documented this outcome measure for two (2) consecutive quarters, maintains compliance through exit from this action, and the Monitor has verified compliance with this outcome measure.

Outcome Measure 4: Search for Relatives

Measure

If a child(ren) must be removed from his/her home, DCF shall conduct and document a search for maternal and paternal relatives, extended formal or informal networks, friends of the child or family, former foster parents, or other persons known to the child. The search period shall extend through the first six (6) month administrative case review following removal from home. The search shall be conducted and documented in at least **85%** of the cases.

Definitions

- Temporary placement with relatives to whom the child is emotionally attached and who can ensure the child's safety may be the most desirable arrangement.
- Placement with a relative or non-relative caretaker with whom the child is familiar requires the completion of an assessment for a relative certification or special study license.

Measurement Procedure

- A. The Monitor shall determine if this outcome has been achieved through DCF quarterly outcome reports. DCF will report quarterly on the barriers to meeting this measure.
- B. The Monitor shall find that DCF has complied with this outcome measure when DCF has documented this outcome measure for two (2) consecutive quarters, maintains compliance through exit from this action, and the Monitor has verified compliance with this measure.

Data Mapping

Pending LINK Change. Release scheduled for June 2004.

Outcome Measure 5: Repeat Maltreatment of In-Home Children

Measure

No more than **7%** of the children who are victims of substantiated maltreatment during any sixmonth period shall be the substantiated victims of additional maltreatment during any subsequent six-month period. This outcome shall begin to be measured within the six-month period beginning March 1, 2004.

Measurement Procedure

- A. The Monitor shall determine if this outcome has been achieved through a LINK six-month outcome report. DCF will report every six (6) months on the barriers to meeting this measure.
- B. The Monitor shall find that DCF has complied with this outcome measure when DCF has documented this outcome measure in LINK for one (1) six (6) month period and maintains compliance through exit from this action, and the Monitor has verified compliance with this measure.

Data Mapping

- Query the LINK database to retrieve all investigations completed during the period 1/1/YYYY – 6/30/YYYY to then determine all associated, substantiated allegations (including type), substantiated victims and designated worker and office.
- Query the LINK database to retrieve all investigations completed during the period 1/1/YYYY – 6/30/YYYY to then determine all associated, substantiated allegations (including type), substantiated victims and designated worker and office.
- Compare the two datasets to determine the substantiated victims contained in both extracts.
- Divide the number of repeat victims by the number of total victims to determine percentage of repeat maltreatment.

Outcome Measure 6: Maltreatment of Children in Out-of-Home Care

Measure

No more than **2%** of the children in out-of-home care on or after January 1, 2004 shall be the victims of substantiated maltreatment by substitute caregivers while in out-of-home care.

Definitions

- Maltreatment by parents or guardians while the child is in out-of-home care are not counted for the purpose of this measurement.
- Regulatory violations are not considered substantiations, and shall be handled as specified in DCF policy.

Measurement Procedure

- A. The Monitor shall determine if this outcome has been achieved through LINK quarterly outcome reports. DCF will report quarterly on the barriers to meeting this measure.
- B. The Monitor shall find that DCF has complied with this outcome measure when DCF has documented this outcome measure in LINK for two (2) consecutive quarters, maintains compliance through exit from this action, and the Monitor has verified compliance with this measure.

Data Mapping

- Query the LINK database to retrieve all investigations completed during the period to then determine all associated, substantiated allegations (including type), substantiated victims and the date of the associated CPS Report(s).
- Query the LINK database to retrieve all Juan F. children in an open placement during the period.
- Compare the two datasets to identify children contained in both extracts to then compare the CPS Report date to the child's placement begin and end date.
- Divide the number of children involved in instances where the CPS Report date fell within the placement dates by the total number of Juan F. children in care during the period.

Outcome Measure 7: Reunification

Measure

At least **60%** of all children who are reunified with their parents or guardians shall be reunified within 12 months of their most recent removal from the child's home.

Measurement Procedure

- A. DCF shall report quarterly on the number of children who are reunified, and what percentage of those were reunified within 12 months of the child's removal from his/her home. DCF will report quarterly on the barriers to meeting this measure.

Outcome Measure 9: Transfer of Guardianship

At least **70%** of all children, whose custody is legally transferred, shall have their guardianship transferred within 24 months of the child's most recent removal from their home.

Outcome Measure 10: Sibling Placement

Measure

At least 95% of the siblings entering out-of-home placement shall be placed together unless there are documented therapeutic reasons for separate placements.

Definitions

Therapeutic reasons include such things but are not limited to situations where siblings are placed with multiple relatives, one (1) sibling requires hospitalization and others do not, where siblings were abused by another sibling, etc. The therapeutic reason the siblings must be placed apart shall be documented in LINK by the DCF supervisor.

Measurement Procedure

Outcome Measure 13: Foster Parent Training

Measure

Licensed DCF foster or pre-adoptive parents shall be offered 45 hours of post-licensing training within 18 months of initial licensure and at least 9 hours each subsequent year. This measure does not apply to relative, special study or independently licensed foster parents for whom 8 hours of pre-service training is required.

Definitions

The Department will ensure that all modules requiring social worker attendance are attended by social workers. At least 80% of all families and children shall have all their medical, dental, mental health and other service needs provided as specified in their most recently approved clinically appropriate treatment plan.

- Adoption and Adolescent specialty workers shall have no more than 20 cases at any time.
- Probate workers shall have no more than 35 cases at any time. When the probate or
 interstate worker is also assigned to provide services to the family, those families shall
 be counted as in home treatment cases with a ratio of 1:20 cases.
- Social workers with in-home voluntary and interstate compact cases shall have no more than 49 cases at any time.

A worker with a mixed caseload shall not exceed the maximum weighted caseload derived from the caseload standards in A through F above.

These standards supersede those of Order No. 441 dated July 29, 2003.

- A. The Monitor shall determine if this outcome has been achieved through LINK daily reports. DCF will report quarterly on the barriers to meeting this measure.

Outcome Measure 19: Reduction in the Number of Children Placed in Residential Care

Measure

The number of children placed in privately operated residential treatment care shall not exceed 11% of the total number of children in DCF out-of-home care.

The circumstances of all children in-state and out-of-state residential facilities shall be assessed after the Court's approval of this Exit Plan on a child specific basis to determine if their needs can be met in a less restrictive setting. The placement of any additional children out-of-state after the approval of this plan shall require the approval of the Transition Task Force.

Definitions

Residential treatment facilities are 24-hour mental health facilities, which operate for the purpose of effecting positive change and normal growth and development for emotionally disturbed, behavioral disordered and socially maladjusted youth. Children are referred through a holistic treatment plan involving DCF staff and mental health professionals. Target Population: seriously emotionally disturbed children up to age 18. State operated facilities, stand alone group homes, Safe Homes, and juvenile justice 24 hour facilities are not included in this measure.

Measurement Procedure

- A. DCF will report on the number of children in in-state and out-of-state residential facilities quarterly. DCF will report quarterly on the barriers to meeting this measure.
- B. DCF will report on its aggregate assessments of the needs of all children placed residentially sorted by in-state and out-of-state.
- C. The Monitor shall find that DCF has complied with this outcome measure when DCF has documented this outcome measure for two (2) consecutive quarters, maintains compliance through exit from this action, and the Monitor has verified compliance with this measure.

Glossary

AFCARS

AFCARS (Adoption and Foster Care Automated Reporting System) is a federal program that requires states to report specific data on every child in the care/custody of the states' child welfare agency during a defined period. AFCARS data and/or data extraction methodology can be reused for the purposes of the Juan F. vs. Rowland Exit Plan in measures that require foster care data spanning a reporting period rather than a specific point in time. Connecticut DCF's AFCARS extract is adjusted for the purposes of this Exit Plan to exclude Juvenile Justice children who are not dually committed.

Court Disposition

Court hearing held subsequent to an adjudication in which the judge after considering the facts of the Social Study and the total circumstances of the child, orders whatever action is in the best interests of the child.

Discharge

Initial Criteria - Discharge from care is determined by first querying the LINK database to retrieve any placements where the placement ending was accompanied by a Yes answer to the question "Is the end of this placement a discharge from all placements?" For placement endings that were designated as a discharge, the following criteria is used to determine a child's actual discharge from care date:

- If the initial discharge criteria is met and there are no subsequent placements, then check for a Court Disposition that contains a change in **Legal Status** to **Not Committed** where the effective date of the court disposition is greater than or equal to the placement end date, use the Effective Date of that Court Disposition as the discharge date.
- If the initial discharge criteria is met and there are no subsequent placements and the child's legal status is anything but **Not Committed** or **Unknown** (conversion) then add six months to the end date of the placement.
- 3. If the initial discharge criteria is met and there are no subsequent placements and there is no legal history then use placement end date as the discharge date.

Effective Date

Data field existing in LINK data window used to record Court Disposition of Legal Activity on a case. This date is used to reflect the actual date that the court ordered activity is effective as of.

Exception Code

Code(s) used to indicate that there are valid reasons for the **Multidisciplinary Evaluation** not being completed in accordance with policy.

Investigation

A fact-finding process that gathers information already begun during the report-taking phase of allegations child abuse, neglect or in danger of abuse. The fact finder (i.e. investigator) must acquire and analyze information to determine whether a child has been abused or neglected and is in need of protective services or other services offered by the Department or the community. **DCF Policy 34-2-2 "Investigation Process"**

Juvenile Justice

A system that provides individualized supervision, care, accountability and treatment in a manner consistent with public safety to those juveniles who violate the law.

LINK

LINK is the agency's Federally subsidized case management system, or SACWIS (State Automated Child Welfare Information System)

Removal From Home

Removals from home are characterized by a placement entry in LINK that is accompanied by a **Yes** answer to the question, "Is this a removal from home?"

Report

Report: is defined as a verbal, written, or in-person communication to the Department that alleges abuse, neglect or in danger of abuse of a person under eighteen (18) years of age, or of a person over eighteen years of age who is a Department client. A "report of alleged abuse, neglect, or a child in danger of abuse or neglect" comes into existence designates a response time for commencement of the investigation. The report is in LINK and can be found under the Intake Icon, CPS Report, RTM (i.e. Response Time Matrix) Tab, Response Time designation. **DCF Policy 33-2 "CareLine: Introduction"**

Service Types are various codes used in LINK when an out of home placement is recorded to designate the specific type of placement. (i.e. "Age 0-5 Foster Care, Shelter – Temporary, Residential Treatment – CPS). Every LINK placement is recorded with a Service Type.

Sibling Placement

A brother and/or sister group should be placed together unless there are documented therapeutic reasons for separate placements. Therapeutic reasons include, but are not limited to situations where siblings are placed with multiple relatives, one sibling requires hospitalization and others do not, where siblings were abused by another sibling, etc. Safety factors and the children's best interests should be considered when making this determination. The therapeutic reason why the siblings must be placed apart shall be documented in the LINK narrative by the DCF Supervisor. Documentation of placements can be found in LINK under the Placement Icon and/or in the LINK narrative.

Transfer of Guardianship

A relative or non-related person who has a judicially created relationship between a child or youth that is intended to be permanent and self-sustaining. This person has the obligation of care and control of the minor child and the authority to make major decisions affecting the child's or youth's welfare.

Treatment Plan

Is a written, clinically appropriate, working agreement between the child, family, caretakers if any, service provider(s) and DCF. The agreement describes and documents the child and/or family's service needs as well as what DCF, the family and/or the child is required to do to achieve the goals of the plan. Clinically appropriate treatment plans are those in which there is a complete and thorough assessment and the goals, and objectives outlined (which are observable and measurable) are appropriately matched to the identified needs, presenting issues and/or problem areas of the child and/or family. A complete and thorough assessment should include the following elements: (1) a

description of household members and status in the family; (2) current issues and reason why the case was open, including presenting issues and problem areas; (3) prior case history with the Department; (4) family issues as perceived by the parent caretaker; (5) family strengths and needs, (6) legal status, including all legal activity and actions, and the status thereof, (7) a description of services offered and provided to prevent removal of the child from the home and/or to reunify the family; (8) overall case goal and how the goal will be measured and achieved; (9) responsibilities and timelines for completing expectations related to the case goal (activities within the planning period); and (10) educational and health considerations presently being addressed; and (11) a synopsis of the current visitation plan (if applicable).

Treatment plans are developed and used to: (1) identify in a time limited and goal oriented format, the problem areas, needs and proposed services to be provided to all children, parents, relatives and caretakers who are active participants in the case; (2) document and describe reasonable efforts to prevent out-of-home placement of children; (3) define mutual responsibilities and expectations of children, parents, caretakers, and service providers towards reaching identified case goals (4) document and describe reasonable efforts to reunify children with their families in a timely manner, and (5) determine sibling and parental visitation schedule if siblings are not placed together.

In addition to the core family treatment plan, there are various additional treatment plans utilized by the Department depending on the type of case being serviced. Each additional plan required should be documented in LINK under the Treatment Planning Icon. These include:

Adolescent Discharge Plan: a written working document between the youth, service providers and the Department Social Worker developed at least 180 days prior to the youth's anticipated discharge from the Department's care. The Discharge Plan should include, but is not limited to the following: the estimated date the youth will leave Department care; the youth's anticipated living arrangements, an estimate budget; sources and amount of income/assets; assistance to be provided by the Department; a schedule for meeting the worker if the youth chooses to meet with the worker; any other plans necessary to facilitate the youth's discharge from care; and to facilitate their ability to maintain permanency post-discharge.

Child in Placement Treatment Plan: a written working document between the child, family, caretaker, service provider and the Department Social Worker. This agreement describes and documents the child's services needs as well as what each party agrees is required to address the service needs and achieve the child's Permanency Plan. A child in Placement Treatment Plan is created for every child in care and reviewed at specific times per policy. A complete and thorough child assessment should include the following elements: (1) a description of the child; (2) the child's strengths and needs; (3) family issues as they pertain to the child; (4) a description of the circumstances leading to the placement episode; (5) prior placement history; (6) reasonable efforts made to reunify the

child with their family in a timely manner, including a description of the services that have been offered and provided; (7) case goal and how it will be measured and achieved; (8) progress and barriers towards meeting the child's permanency goal; (9) concurrent planning steps (when reunification is the goal); (10) mutual responsibilities and expectations of children, parents, caretakers, and service providers for reaching identified case goals; (11) legal activity and status; (12) educational status/issues; (13) MDE results and plant to address results/health considerations; and (14) a synopsis of the current visitation plan.

Health Treatment Plan Addendum: A plan developed for every child in out-of home care, or for a child who is a member of a family receiving treatment services that has a documented unmet medical need. The plan shall describe a procedure for gathering any diagnostic/assessment needed and shall specify any and all health services to be provided to the child and/or the child's biological parents.

Independent Living Case Plan: a written working document between the youth, service providers and the Department Social Worker to enable permanency through independent living. This plan is documented on DCF form 2091 which includes information in the following areas: Education, Vocation, Employment/Life Skills, Housing, Financial, Health, Mental Health, Substance Abuse, Parenting, Legal Issues and Obtaining Essential Documents. Every DCF youth in out-of-home care, age sixteen or older, shall have an Independent Living Case Plan, unless there is a documented reason as to why the youth cannot live independently.
